- 11.2 participation in animal handling is a hazardous activity and may result in injury, loss, damage or death to me;
- participation in animal handling requires certain skills and experience. I declare that I have sufficient skills and experience to be able to safely and properly participate in the events;
- animals can act in sudden and unpredictable ways, especially if frightened or hurt, or if exposed to loud or unfamiliar noises;
- animal showing events may be held in close proximity to loud and unfamiliar noises which can frighten animals.
- if the event is held outdoors, there are risks to me as a result of weather conditions, including extreme hot or cold weather, rain or wind;
- 11.7 insects or other animals may cause animals to become frightened and act in an unpredictable way;
